

# TAILGATING CONTRACT

1. \_\_\_\_\_ I understand that the event host will be responsible for the assignment of all tailgating spaces. I further understand, that the School Board of Richmond County does not allow the use of alcohol, drugs, or weapons on School District properties. Weapons are strictly prohibited in schools or on school grounds. It is against the law (O.C.G.A. 16-11-127.1) to carry a weapon on school property and at school functions. Any person in violation of this policy is subject to removal from tailgating, loss of tailgating space and penalties, all applicable fines, and prosecution by Augusta Richmond County Law Enforcement.
2. \_\_\_\_\_ I understand that my tailgating space is not a vendor space and the sale of merchandise or food is **NOT** permitted. Violation will result in the loss of tailgating space.
3. \_\_\_\_\_ I understand that the event host is **NOT** responsible for any damaged or stolen properties during the event. The event host is not responsible for any injuries.
4. \_\_\_\_\_ I understand that the responsible party (i.e., tailgater) must remove all trash and possessions from assigned space no later than 10:00pm on the day of the event. I agree to begin breaking down tents and packing up at the start of the 4<sup>th</sup> quarter. Failure to remove all items from premises may result in a fine and legal action. I also understand that it is a major violation to pour grease or other damaging substances on the parking lot and that as the responsible party for the tailgate spot I will be subject to a fine if found to be in violation.
5. \_\_\_\_\_ I understand that I will not be able to set up my tailgate space until September 22, 2023 at 4:00pm on the day of the event and that I will only be allowed to occupy the spaces I am assigned. I further understand that any unapproved occupancy of spaces will be subject to towing. I also understand that this tailgating fee is nonrefundable.
6. \_\_\_\_\_ I understand that participants (i.e., tailgaters) participate at their own risk and that neither the Richmond County School System nor Westside High School will be held responsible or liable for any accident, damage, loss of items/materials, or injury during or as a result of this event.
